

Dear Reverend.ma.Agostino Vallini,



We have appointed the attorney of the Holy See and Roman Curia avv. Carlo GULLO to represent us (see attached mandate) in front of the tribunal and he will bring the case and the rationale for our petition.





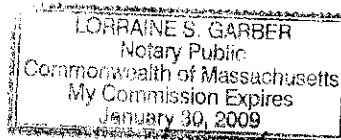
